THE ORDER OF FEB. 11, 2022, (ECF 12) ENJOINING  
JASON GOODMAN FROM CONTACTING COURT STAFF**

**MOTION FOR LIMITED INTERVENTION  
TO CORRECT ECF 12, ORDER of 2/11/2022**

**BACKGROUND**

NOW COMES MOVANT D. GEORGE SWEIGERT, *pro se* non-attorney third-party, to request limited permissive intervention pursuant to F.R.C.P. Rule 24(b). The Movant is the brother of Plaintiff George Webb Sweigert, aka “GEORGE WEBB” in social media podcast circles. The Movant was the Appellant in the action *UNITED STATES of America, ex rel. David George SWEIGERT, Plaintiff-Appellant vs. ELECTRONIC SYSTEMS ASSOCIATES, INC.; Lemuel Kinney, Defendants-Appellees*, 85 F.3d 630, Sixth Circuit, May 16, 1996.

The ORDER (ECF 12) of 2/11/2022 states “See *Sweigert v. Goodman*, No. 18-CV-8653, 2022 U.S. Dist. LEXIS 251325, (S.D.N.Y. Jan. 19, 2022)” (ECF No. 12, PageID.126 Filed 02/11/22 Page 1 of 5). The Movant is the Plaintiff in that action in the S.D.N.Y. and not “GEORGE WEBB” (the Plaintiff).

Jason Goodman filed an Amicus Brief in litigation (docket 20, **2:20-cv-12933-GAD-KGA, *Sweigert v. CNN***) which alleged some kind of vague fraud upon the court perpetrated by the Clerk of the Court, who apparently was in a conspiracy with the Plaintiff “GEORGE WEBB” according to Mr. Goodman.

Jason Goodman has also filed an action against “GEORGE WEBB” (Plaintiff) in the S.D.N.Y., Case 1:21-cv-10878-AT-JLC; *Goodman vs. Christopher Ellis Bouzy, BOT Sentinel, Inc., and George Webb Sweigert*. The initial complaint in 1:21-cv-10878 references docket no. 20, Amicus Brief, which was filed in **2:20-cv-12933-GAD-KGA, *Sweigert v. CNN***.

The initial complaint in S.D.N.Y. 1:21-cv-10878 claims that the Amicus Brief filed in *Sweigert v. CNN* accuses the Plaintiff of criminal activity in a conspiracy with the Clerk of the Court. Quoted below in relevant part:

*18. On or around December 17, 2021, coincident with a filing by Webb in Sweigert v CNN (See Case 2:20-cv-12933-GAD-KGA ECF No. 35) Bouzy republished his 2020 defamatory statements intended to injure Plaintiff.*

*19. Plaintiff has submitted an Amicus Curiae brief in Sweigert v CNN that alleges criminal activity on the part of Webb and others. (See Case 2:20-cv-12933-GAD-KGA ECF No. 20)*

On or about January 29, 2022 Jason Goodman, who is the owner of a New York State chartered corporation known as Multimedia System Design, Inc. (MSDI) published video content implying that Richard Lourey was involved in a criminal conspiracy related to judicial corruption. URL: <https://www.youtube.com/watch?v=7LlPmHUz7Qs> (see “Judge Valerie E. Caproni, Multimedia System Design, Inc. d/b/a “Crowdsource the Truth” (“MSDI”) produces video content that, *inter alia*, traffics in wild conspiracy theories.” *Nat’l Academy of Television Arts & Sciences v. Multimedia Sys. Design, Inc.*, 20-CV-7269 (VEC), (S.D.N.Y. Jul. 30, 2021)).

On Jan. 28, 2022, Jason Goodman, d/b/a as CrowdSource The Truth, published a Twitter tweet after hanging up the phone with Richard Loury of the Michigan Eastern District court staff.




The above tweet makes reference to a CrowdSource The Truth social media podcast known as the “COUNTER LAWFARE REPORT”. Described more fully with a document filed immediately after the Amicus Brief (attached as Exhibit One as a convenience).

### PERMISSIVE INTERVENTION FOR LIMITED PURPOSES

Movant submits this limited F.R.C.P. Rule 24(b) request in a timely manner and asserts a common question of law or fact, which does not prejudice the original party. Rule 24(b) grants the district court discretionary power to permit intervention if the motion is timely, *NAACP v. New York*, 413 U.S. 345, 365-66, 93 S.Ct. 2591, 2602-03, 37 L.Ed.2d 648 (1973). “Regarding permissive intervention, "so long as the motion for intervention is timely and there is at least one common question of law or fact, the balancing of undue delay, prejudice to the original parties, and any other relevant factors is reviewed for an abuse of discretion." *Miller*, 103 F.3d at 1240.” *Stupak-Thrall v. Glickman*, 226 F.3d 467 (6th Cir. 2000).

Jason Goodman, d/b/a CrowdSource The Truth, has accused the Movant, Plaintiff and Richard Loury (MARIO BROTHERS and their accomplice) of criminal activity in social media podcasts that amplify his allegations raised in *Goodman v. Bouzy, Bot Sentinel, Inc., and Sweigert*. The Movant has a substantial interest in this case. *Grutter v. Bollinger*, 188 F.3d 394 (6th Cir. 1999).

The Movant is “uniquely situated” to provide information to this Court for the purposes of correcting the ORDER of 2/11/2022 (ECF 12). Turning to the wisdom of the Western District of Michigan in *United States v. ABC Industries*, 153 F.R.D. 603 (W.D. Mich. 1993) which relied upon *Utah State Dep't of Health v. Kennecott Corp.*, 801 F.Supp. 553, 572 (D.Utah 1992) (denying " intervention of right" but granting " permissive intervention" to a party " uniquely situated to significantly contribute to the underlying factual and legal issues" ) and *United States v. Acton Corp.*, 131 F.R.D. 431 (D.N.J. 1990) (allowing intervention under Rule 24(a)(2) and CERCLA Section 113(i)).

**SUBJ: WARNING CONCERNING ALLEGED WIRE FRAUD**

**SIR/MADAM:**

1. Essentially this communication creates allegations concerning Patreon knowingly broadcasting video content produced by an enterprise known as CROWDSOURCE THE TRUTH, which operates the COUNTER LAWFARE FUND, that smacks of wire fraud.
2. The latest “litigation stunt” perpetrated by the CROWDSOURCE THE TRUTH enterprise appears to have been video content placed on Patreon that describes a purported act of judicial corruption. The video speakers claim to have evidence of such “corruption” in a federal court. These assertions appear to be knowingly false with regards to any “corruption”.
3. As you are well aware New York City attorney John H. Snyder has appeared on these COUNTER LAWFARE Patreon podcast shows. Specifically, a podcast video that directly addressed “fraud on the court” and/or “corruption” in the federal courts of Detroit, Michigan.
4. These artifacts of so-called “stunt litigation” are the brainchild of the attorneys and para-legal staff that seem to orbit CROWDSOURCE THE TRUTH like flies. This group produces *criminal indictments* as part of its *Citizens Grand Jury* hoax. Some broadcasts appear to intimidate federal jurists with social media slurs and smears unless a judicial verdict is rendered, or a case heard.

5. The latest alleged instantiation of wire fraud is the transmission of a fraudulent artifact to the U.S. District Court serving Detroit, Michigan, an alleged “fraudulent artifact” known as **ECF document number 20**.

6. John H. Snyder, esq., affirmatively participated in creating said video content (Michigan court “corruption”) and may have ghost written **ECF document 20**, which can be said to imply the use of judicial intimidation, through the use of social media, to slur and smear court officials.





7. Documents filed in federal court suggest that you (Patreon) have exchanged e-mail messages with CROWDSOURCE THE TRUTH after you were made aware of racketeering allegations in 2018. See **EXHIBIT C-24** in attachment.

8. These acts of “stunt litigation”, that are promoted on Patreon, represent staged litigation drama and are used to apparently fuel fundraising by this group. The same group with which you (Patreon) apparently exchanged e-mail messages on December 8, 2020 to coordinate the filing of other artifacts of “stunt litigation”. [**EXHIBIT C-24**]

9. As Larry Klayman, esq. is associated with this group, there is a wealth of expertise in this area of the creation of so-called sham documents which smack of stunt litigation. This sham stunt litigation drama then becomes the subject of Patreon and YouTube video podcasts that push fund raising for the COUNTER LAWFARE fund (see broadcasts on 01/06/2021 at the U.S. Capitol sponsored by CROWDSOURCE THE TRUTH). All this activity is alleged to fuel a racketeering enterprise.

10. Patreon will recall the video podcast series created by the COUNTER LAWFARE REPORT and Brian Vukadinovich, Crown Point, Indiana, that smeared and slurred several Indiana federal judges on the COUNTER LAWFARE REPORT.
